


Accessing Services

Victims of exploitation and human trafficking may be apprehensive to accept assistance for reasons beyond their trauma experiences. Other reasons may include:

- Lack of knowledge about resources and legal protections
- Fear of governmental agencies
- Fear of deportation
- Fear of threats to loved ones
- Language barriers

The keys are to work through these barriers by:

- Building a relationship of trust
- Setting clear expectations
- Bridging language barriers
- Utilizing trauma-informed resources



Key Ingredients of Trauma-Informed Clinical Practices



Involve patient in treatment process

For example, no surprises! Also, include bedside advocates with lived expertise and experiences (S.H.A.D.E., Ruby's Place, Progressive Transition(s), etc.)



Screen for trauma

Upfront screening for Adverse Childhood Experiences (ACE), exploitation and trafficking, etc. (This may be difficult without first building trust through first universally assessing patient's well-being!)



Train staff in trauma-specific approaches

See handout.



Engage referral sources and partnering organizations for:

- Short-term and immediate needs: internal advocates and/or external certified and trained bedside advocates
- Longer-term, trauma-informed, case-managed supports in legal matters, etc.

Challenges That Can Undermine Care

Lack of Shelter and Housing

- Alameda County lacks sufficient housing options However, see the Frequently Contacted Organizations list
- Ruby's Place has emergency shelters for adult age men and women (but not children)
- Ruby's Place and Building Futures for Women and Children have Rapid Re-Housing Support for longer-term housing (Section 8 Vouchers)
- DreamCatcher has emergency beds for youth (13 to 17) and Covenant House for young adults (up to 23)
- Alameda County does not have Short-Term Residential Treatment Housing for child welfare dependents

Lack of Long-Term Case Management


- Most long-term case managers are residential based, such as Ruby's Place and Side by Side Youth. Outpatient case managers are at Ruby's Place Outreach and Progressive Transition(s).
- Tahiri Justice Center and Justice At Last offer traumainformed legal services that include case management for clients.
- Alameda County Family Justice Center has short-term navigators for DV and Sexual Assault.

Key Challenge: Mental Health Care

Long-term, affordable, one-on-one mental health care — coupled with group-based care when appropriate — is critical for exploited patients, yet not easily available.

WestCoast Children's Clinic in Oakland has a specialized mental health practice for youth at risk or involved in commercial sexual exploitation, and has published a practice guide: Psychotherapy for Commercially Sexually Exploited Children: A Guide for Community-Based Behavioral Health Practitioners and Agencies

The guide's content and guidance may be applicable to adult-age victims of both labor and sex trafficking. An integrated mental health treatment framework for exploitation is suggested. https://www.westcoastcc.org/wp-content/uploads/2018/10/MH Treatment Guide CSEC.pdf



Role of Health Champions

- Serve as internal expertise on services and approaches to support suspected or confirmed human trafficked/exploited patients to health professionals in the targeted health settings.
- Lead development of protocols and trainings for effective implementation – designate space to interview victims and resources for emergency needs.
- Participate in learning exchanges with fellow community health centers, hospitals, and stakeholders to sharpen implementation practices.
- Report cases and make data-informed decisions to provide any course corrections, identify breakthroughs, etc. throughout implementation.
- Serve as the lead contact from health facility to the Community Health Center Network and other partners of the Human Trafficking Medical Offramps Project.


Community-Based

Resources Available

Bedside Advocates Managed by S.H.A.D.E.

Duties Monday through Friday 8 am to 5 pm

- Certified in domestic violence, sexual assault, and human trafficking counseling; maintain patient's confidentiality and expectations
- Skilled in culturally-competent and language- specific services
- Equipped with basic toiletry bag; if allowed, transport client to place of safety
- Set up and hand-off to long-term case management and follow patient
- Keep health care provider informed about warm hand- off to long-term case management services





Community Health Center Network

- Coordinate protocol development/implementation with training at community health centers
- Convene learning communities between hospitals that have completed training and protocol development and community health centers
- Introduce community-based resources to support patient's healing
- Analyze prevalence data collected from community health centers and rolling up to the State



H.E.A.T. Watch


Five-point strategy that includes:

- A survivor-based advocacy organization that offers training, court advocacy, support groups, leadership programming, and crisis intervention to survivors/ victims of exploitation
- Founder co-founded Motivating Inspiring Supporting and Serving Sexually Exploited Youth, based in Oakland
- Bedside Advocates respond to patient needs while at health setting and link patients to longer-term case management
- Bedside Advocates from S.H.A.D.E., Ruby's Place, Progressive Transition(s), and Bay Area Women Against Rape are dispatched to arrive within 60 minutes from when the call is received through the S.H.A.D.E. Hotline.

Almeda County Social Services Agency

Case Managers determine eligibility, complete and submit applications for the following benefits:

- CalFresh, Cash Assistance, MediCal, WIC (children under 5 yrs.)
- Programs have eligibility requirements NOT open to everyone
- U visas: Access to benefits Proof of Visa application
- T visas: Can seek benefits BEFORE starting visa application
- No SSN required

Under 19 yrs. Old: Social Security number is not needed

- CalFresh & WIC access
- Medical insurance (MediCal) for minors

Bay Area Women Against Rape





2020 Wage & Hour Laws

Employer must provide employees, regardless of immigration status

- Payment for ALL time worked and must pay Overtime anytime employees work over 8 hours per day or 40 hours per week
- Minimum Wage: \$12 per hour in CA; \$13.80 to \$14.14 per hour in Oakland, in San Francisco \$15.59 per hour and Emeryville \$16.30 per hour
- Breaks for rest and meals (10 minute break every 4 hours, 1 lunch break if work exceeds 5 hours)

Employer cannot make illegal deductions from employee pay for food, housing, or debts owed, regardless of employee immigration status

Employees have 1 to 4 years to make legal claims against employers, if employer: did not adhere to an agreement or contract; physically hurt, harassed, abused, or psychologically or emotionally scared employee; prevented employee from leaving by holding onto passport, lying to them, or physically limiting their freedom of movement

Employers must physically post in different languages these laws

Step 1:

Contact internal hospital/community health center champions and follow internal protocols

Step 2:

Universally assess patient and screen for exploitation

Step 3:

Secure patient's consent to call Bedside Advocate, law enforcement and abuse hotlines

Step 4:

Contact Bedside Advocates:

Survivors Healing Advising and Dedicated to Empowerment
 Hotline (510) 437-0192 to access advocates from S.H.A.D.E., Ruby's Place, Progressive Transition(s), or BAWAR

Step 5:

Make interview room available, inform patient of next steps, and review Bedside Advocate's credentials

Patient A Scenario

16-year-old female accompanied by her aunt comes to the health center about 3pm in the afternoon complaining about headaches and pelvic pains. The female appears highly agitated and asks the aunt to join her in the examination room. The nurse notices the aunt is intermittently texting on her cell phone. During the exam, the physician notices tattoos on the patient's upper thigh, chest, and midriff that say, "Thoroughbred."



Patient B Scenario

A 19-year-old male comes in at 9:00 am. He is sweating, flustered, and most importantly has what appears to be a twisted right forearm and a dislocated left shoulder. He wants pain medicine and a splint, and he needs them quickly. He says that his uncle is waiting in the car.
